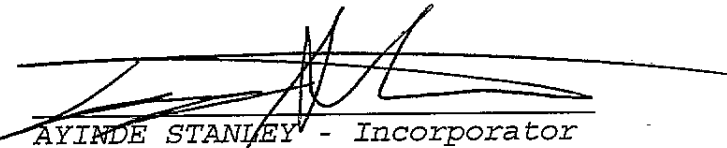
**ARTICLE IX INITIAL BOARD OF DIRECTORS**

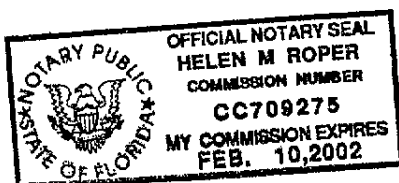
