The undersigned, acting as Incorporator of a professional corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

1. **NAME.** The name of the corporation is **THERESE A. PIKE, P.A.**

2. **PRINCIPAL OFFICE/MAILING ADDRESS.** The principal office and mailing address of the corporation is 298 Pineapple Grove Way, Delray Beach, Florida 33444.

3. **SHARES.** The number of shares the corporation is authorized to issue is one hundred (100) shares. The par value for the authorized shares is One Dollar (\$1.00).

This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
