

ARTICLES OF INCORPORATION

OF Ron's Foliage Inc.

The undersigned subscriber to these Articles of Incorporation, being natural persons and competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is Ron's Foliage Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 1365 E. Hubbard Ave., DeLand, Florida 32724.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to have outstanding at any one time is One Hundred (100) shares of Common Stock, having a par value of One Hundred and No/100 Dollars (\$100.00) per share. Each share of stock shall be entitled to one vote, non-cumulative and shall be subject to such restrictions of transfer thereof as may be hereafter adopted by the shareholders and included in the By-Laws of this corporation.

ARTICLE IV - INITIAL REGISTERED AGENT AND ADDRESS

ARTICLE VI - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE VII - PURPOSE

This corporation is formed for the following purposes:

1. To purchase, receive by way of gift, subscribed for, invest in, and in all other ways acquire, import, lease, possess, maintain, handle on consignment, own, hold for investment or otherwise, use, enjoy, exercise, operate, manage, conduct, perform, make, borrow, guarantee, contract in respect of, trade and deal in, sell, exchange, let, lend, export, mortgage, pledge, deed in trust, hypothecate, encumber, transfer, assign and in all other ways dispose of, design, develop, invent, improve, equip, repair, alter, fabricate, assemble, build, construct, operate, manufacture, plant, cultivate, produce, market, and in all other ways (whether like or unlike any of the foregoing), deal in and with property of every kind or character, real, personal or mixed, tangible or intangible, wherever situated and however held, including, but not limited to, money, credits, choses in action, securities, stocks, bonds, warrants, script, certificates,

debentures, mortgages, notes, commercial paper, and other obligations and evidences of interest in or indebtedness of any person, firm or corporation, foreign or

domestic, or of any government or subdivision or agency thereof, documents of title, and accompanying rights, and every other kindand character of personal property, real property (improved and unimproved), and the products and avails thereof, and every character of interest therein and appurtenance thereto, including, but not limited to, mineral, oil, gas, and water rights, all or any part of any going business and its incidents, franchises, subsidies, charters, concessions, grants, rights, powers or privileges, granted or conferred by any government or subdivision or agency thereof, and any interest in or part of any of the foregoing, and to exercise in respect thereof all of the rights, powers, privileges, and immunities of individual owners or holders thereof.

- 2. To hire and employ agents, servants, and employees, and to enter into agreement of employment and collective bargaining agreements, and to act as agent, contractor, trustee, factor, or otherwise, either alone or in company with others.
- 3. To promote or aid in any manner, financially or otherwise, any person, firm, association or corporation, and to guarantee contracts and other obligations.
- 4. To let concessions to others to do any of the things that this corporation is empowered to do, and to enter into, make, perform, and carry out, contracts and arrangements of every kind and character with any person, firm, association or corporation, or any government or authority or subdivision or agency thereof.

ARTICLE VIII - INITIAL CAPITAL

The amount of capital with which this corporation shall begin business shall not be less than One Thousand and No/100 Dollars (\$1,000.00).

ARTICLE IX - INITIAL BOARD OF DIRECTORS

The number of directors of this corporation shall not be less than one (1) nor more than three (3), as shall from time to time be fixed by the By-Laws of the corporation, and the following are the names and addresses of the initial Directors, who, subject to the provisions of these Articles, the By-Laws of this corporation, and the laws of the State of Florida, have agreed to take the following shares of the capital stock of the stock of the corporation at par value:
