The undersigned subscribers to these Articles of Incorporation, each natural persection to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

<u>ARTICLE I NAME</u>

The name of the corporation is:

ARTICLE II NATURE OF BUSINESS
