**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
SCHOFIELD ALLEN DESIGN GROUP, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, Schofield Allen Design Group, Inc., a Florida Corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

**Amendment**

The Corporation's Articles of Incorporation are amended by deleting the existing Article I and inserting the following in its stead:

**ARTICLE I NAME**

The name of the corporation is *The Floor Source and Design Center, Inc.* (the "Corporation").

**Date of Adoption**

The amendment was adopted on the 27th day of October, 1998.
