ARTICLE X - AMENDMENT

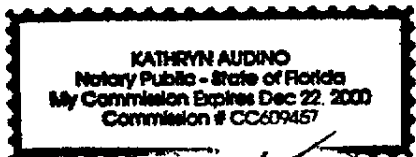




