ARTICLES OF INCORPORATION

ARTICLE I

The name of this Corporation shall be: CDS Air Freight NDO Inc.



ARTICLE II

Subject to the provisions of the laws of the State of Florida, specially Chapter 607, Florida Statues and all other applicable laws, rules and regulations, this Corporation shall come into existence at 12:01 A.M. on August 18, 1998.
