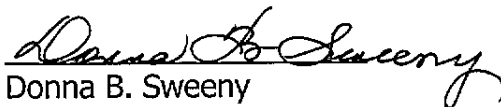

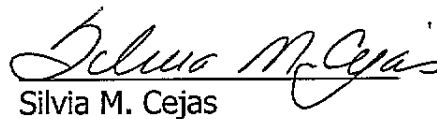

We, the undersigned, do hereby associate ourselves together and subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and subject to the following provisions;

**ARTICLE ONE**

The name of the corporation shall be:

**ARTICLE TWO**

The corporation may engage in any activity of business permitted under the laws of the United States of America and of the State of Florida.

**ARTICLE THREE**

The maximum numbers of shares of stock, which the corporation shall have outstanding at any time, shall be 10,000 Shares of stock, which shall be common stock of a par value of 1.00 Dollar per share. ## **ARTICLE TWELVE**

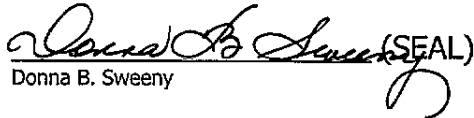

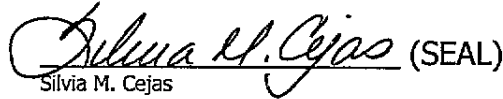
