ARTICLES OF INCORPORATION
OF
ANSTE INTERNATIONAL, INC.

The undersigned subscriber to these Articles of Incorporation a natural person competent to contract hereby forms a corporation under the laws of the State of Florida.

ARTICLE I
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the corporation shall be:
ANSTE INTERNATIONAL, INC.

The principal place of business of this corporation shall be One Financial Plaza, Suite 1610, Ft. Lauderdale, Florida 33394.

ARTICLE II
AUTHORIZED SHARES TO BE ISSUED

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having no par value per share.

ARTICLE III
PREEMPTIVE RIGHTS

Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares held by each at the time of issue to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not exercise a preemptive purchase right hereby granted within thirty (30) days of receipt of notice of such in writing from the corporation. The notice of issue of additional shares of stock shall include the price, terms and conditions of the issue and inform each shareholder of the preemptive right. Preemptive rights may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

ARTICLE IV
ADDRESS OF INITIAL REGISTERED AGENT




