ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE I: NAME

The name of this corporation is UNLIMITED SPORTS, INC.

ARTICLE II: CORPORATION'S PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 27093 61st Road, Branford, Florida 32008. The mailing address of the corporation is P.O. Box 270, Branford, Florida 32008.

ARTICLE III: DURATION

The duration of this Corporation is perpetual.

ARTICLE IV: NATURE OF BUSINESS

The general purposes for which the corporation is organized are:

1. To engage in the business of promotion of motor sports events and other sporting events.
