**ARTICLES OF INCORPORATION**

**OF  
YENOLL CORPORATION.**

**THE UNDERSIGNED ACTING AS SUBSCRIBER OF A CORPORATION UNDER THE FLORIDA CORPORATION LAW, ADOPT THE FOLLOWING ARTICLES OF INCORPORATION FOR SUCH CORPORATION.**

**ARTICLE I**

**THE NAME OF THE CORPORATION IS, YENOLL CORPORATION.**

**ARTICLE II**
