# ARTICLES OF INCORPORATION

OF

## U. S. PRESSURE CLEANING, INC.

The undersigned, being of legal age and a natural person, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation for profit under the laws of the State of Florida.

#### ARTICLE I

#### **NAME**

The name of the corporation is **U. S. PRESSURE CLEANING, INC.** (hereinafter referred to as the "Corporation"). The principal office and mailing address of the Corporation is 1103 Copley Court, Boynton Beach, FL 33462.

#### ARTICLE II

#### **PURPOSE**


