

ARTICLE ONE

The name of the corporation is Golden Treasure Restaurant, Inc. and its principal office is at 3335 43rd Street North, St. Petersburg, FL 33713.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is to acquire and operate a restaurant and to perform any services or business incidental thereto. Further, the purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

The Board of Directors is empowered to make, alter, or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.



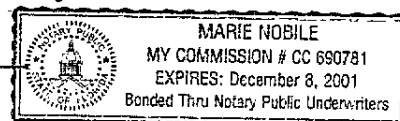


