ARTICLES OF INCORPORATION

OF

T.J. HEALTH & FITNESS, INC.



ARTICLE I. NAME

The name of this corporation is T.J. HEALTH & FITNESS, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing upon the filing of these Articles.
