ARTICLES OF INCORPORATION

OF

I, M. JAY LANCER, the undersigned subscriber of these preficies of Incorporation, a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is: LOKER, INC.

- (a) The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
