# ARTICLES OF INCORPORATION OF ARTISTIC DETAILING INC.

A FLORIDA CORPORATION

THE UNDERSIGNED HEREBY MAKES, SUBSCRIBES, ACKNOWLEDGES AND FILES THE FOLLOWING ARTICLES OF INCORPORATION:

#### ARTICLE I

THE NAME OF THIS CORPORATION SHALL BE:
