ARTICLES OF INCORPORATION INDRIO DEVELOPMENT CORPORATION

SECRETARY OF STATE

The undersigned incorporator, for the purpose of forming a corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is INDRIO DEVELOPMENT CORPORATION (the "Corporation").
