
ARTICLE X

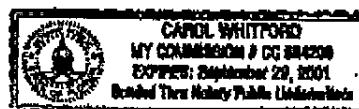
