ARTICLES OF INCORPORATION

OF

STAR CONNECTIONS INC.

The undersigned, for the purpose of forming a corporation for profit under the Florida General Corporation Act, do hereby adopt the following articles of incorporation.

ARTICLE I

EFFECTIVE DATE

STAR CONNECTIONS INC.

The name of the corporation shall be: Star Connections Inc.

ARTICLE II

DURATION

The corporation shall have perpetual existence with an effective commencement date of September 1, 1998.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized are:

- 1. To engage in the business of retail/wholesale sales and trucking transport.
- 2. To transact any other lawful business activity for which corporations may be incorporated under the Florida General Corporation Act.

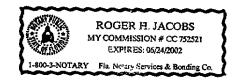
