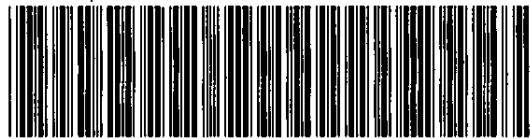

Pursuant to the provisions of Sections 607.1001, 607.1003 and 607.1006, Florida Statutes, the undersigned corporation, ROSEMARY BEACH REALTY INC., a Florida corporation (the "**Corporation**"), adopts the following Articles of Amendment to amend its Articles of Incorporation to change its corporate name:

1. **Name of Corporation.** The name of the Corporation is Rosemary Beach Realty Inc.

2. **Text of the Amendment.** The amendment is to change the Corporation's corporate name (the "**Amendment**"). Accordingly, Article I of the Articles of Incorporation is amended in its entirety to read as follows:
