**ARTICLES OF INCORPORATION**  
**OF**  
**Francis & Associates Inc.**

The undersigned, acting as incorporator if this corporation under the provisions of Chapter 607 of the Florida Statutes, as amended, adopts the following Articles of Incorporation:

**ARTICLE I: NAME OF THE CORPORATION**

The name of the corporation is Francis & Associates Inc., herein-after referred to as the "Corporation".

**ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office and mailing address of the Corporation is at 8340 NE 2nd Ave. Suite 225 Miami, Florida 33138.

**ARTICLE III: DURATION OF THE CORPORATION**

The period of duration of the corporation shall be perpetual unless dissolved according to law.

**ARTICLE IV: PURPOSE OF THE CORPORATION**
