THAT EFFORT RESULTED TO ALL THE FORMS WERE BEING MAILED TO EACH CORPORATION'S, BY MARCH 31ST, 2004. SOME OF THE CORPORATIONS RECEIVED A POSTCARD, "STATING, THAT THE POSTCARD WAS TO BE MAILED BACK - IN ORDER TO RECEIVE THE UNIFORM BUSINESS REPORT OR TO FILE THE FORM ON INTERNET..
