ARTICLES OF INCORPORATION

ARTICLE I. - NAME

The name of this corporation is CALJO, INC.

ARTICLE II. - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III. - CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of voting common stock having a par value of \$1.00 each. All issued shares of capital stock shall be deemed fully paid and non-assessable. All persons who shall acquire stock in this corporation shall acquire the same subject to the provisions of these Articles of Incorporation as amended from time to time.

All or any part of the capital stock of this corporation may be issued for property, labor or services, or for other consideration having a value in the opinion of the Board of Directors at least equal to the full value of the stock to be so issued.

Except as otherwise provided by law the entire voting power for the election of directors and all other purposes shall be vested exclusively in the holders of outstanding voting common shares. As to all matters other than the election of directors, the holders of the voting common stock shall have one (1) vote per share.

As to the election of directors, the nolders of the voting common stock shall be entitled to vote in the manner specified by Article VIII of these Articles of Incorporation.

ARTICLE IV. - PRE-EMPTIVE RIGHTS

Each shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price upon which it is offered to others.

ARTICLE V. - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 3150 Florida Coach Drive, Kissimmee, Florida 32741 and the name of the initial registered agent of this corporation at that address is Caleb S. Calhoun.

ARTICLE VI. - INITIAL BOARD OF DIRECTORS

This corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time by the by-laws, but shall never be less than one. The name and address of the initial directors of this corporation are:

ARTICLE VII. - INCORPORATOR

ARTICLE VIII. - CUMULATIVE VOTING

At each election for directors, every shareholder entitled to vote at such election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing such votes under the same principle among any number of such candidates.

ARTICLE IX. - CALLING OF SPECIAL MEETINGS

Special meetings of shareholders may be called by the Board of Directors or by the holders of not less than one-tenth of the shares entitled to vote as such special meetings.

ARTICLE X. - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.
