Pursuant to our recent conversation, please find enclosed the Corporation Reinstatement for the above captioned corporation along with check number 1459 in the amount of \$300.00 which covers the fees currently due.

The purpose of this letter is to advise you of the circumstances surrounding the administrative dissolution of Gulfcoast Sailing, Inc. and ask your consideration in waiving the fees for reinstatement of same.

Gulfcoast Sailing, Inc. was incorporated to do business in the State of Florida on August 24, 1998, at which time Jennifer D. Elder was the principal shareholder. Ms. Elder handled all administrative affairs of Gulfcoast Sailing, Inc. On or about April 20, 2000 Ms. Elder resigned from Gulfcoast Sailing, Inc. and sold her interest to Mr. Barry. Upon her resigning she advised Mr. Barry that all matters with the Division of Corporations had been taken care of and the corporation was current with the Secretary of State.
