<u>ARTICLES OF INCORPORATION OF</u> <u>DAFNE, S.A.</u>, Inc.

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the Laws of the State of Florida.

ARTICLE ONE - NAME

The name of the corporation is DAFNE, S.A., Inc.

ARTICLE TWO - BUSINESS AND PURPOSE

The corporation is organized for any lawful purpose pounder the Laws of the State of Florida.

ARTICLE THREE - ADDRESS OF CORPORATION

The principal office and the mailing address of the corporation shall be 6979 Collins Avenue, Miami Beach, FL 33141.

ARTICLE FOUR - TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE FIVE - CAPITAL STOCK

The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 100 shares of common stock with a par value of \$1.00 per share. Each share of said stock shall entitle the holder thereof to one vote at every annual or special meeting of the stockholders of this corporation. The consideration for the issuance of said shares of capital stock may be paid, in whole or in part, in cash, in other property (tangible or intangible) or in labor or services actually performed for this corporation, at a fair valuation to be fixed by the Board of Directors. In the election of directors of this corporation, there

shall be no cumulative voting of the stock entitled to vote at such election.

ARTICLE SIX - INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this corporation and the initial registered agent of this corporation shall be: Jeffrey Exposito, Esq., JEFFREY EXPOSITO, P.A. 300 - 71st Street, Suite 527 Miami Beach, Florida 33141.

ARTICLE SEVEN - BOARD OF DIRECTORS

The Board of Directors of this corporation shall consist of not less than one nor more than nine members, the exact number of directors to be fixed from time to time by the stockholders or by the by-laws. ARTICLE NINE - BY-LAWS

The power to adopt the by laws of this corporation, to alter, to amend or repeal the by-laws, or to adopt new by-laws shall be vested in the Board of Directors of this corporation, provided however, that any by-law or amendment thereto as adopted by the Board of Directors may be altered, amended or repealed by the vote of the stockholders entitled to vote thereon, or a new by-law in lieu thereof may be adopted by a vote of the stockholders.
