ARTICLES OF INCORPORATION
OF

The undersigned subscriber, being of natural person,
competent to contract for the purpose of forming a corporation
under the laws of the State of Florida, adopts the following
Articles of Incorporation for such corporation:

ARTICLE I

The name of the proposed corporation is

ARTICLE II

The purpose for which this corporation is organized is to
engage in any activity or business permitted under the laws of
the United States and the State of Florida, including the
