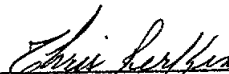
ARTICLE XI

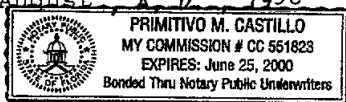

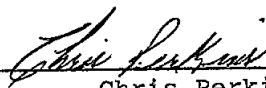
