# ARTICLES OF INCORPORATION

The undersigned incoporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

#### ARTICLE I

Name. The name of the corporation shall be Century Publishing Inc.

### ARTICLE II

<u>Business and Activities.</u> This corporation may, and is authorized to engage in any activity or business permitted under the laws of the United States and the State of Florida.

# ARTICLE III

<u>Capital Stock.</u> The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of voting common stock having a par value of \$1.00 per share, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors. Except for voting rights, the stock authorized hereby have the same rights and preferences.



#### ARTICLE IV

<u>Term of Existence</u>. This corporation shall have a perpetual existence.

#### <u>ARTICLE V</u>

Initial Registered Office and Agent. The street address of the initial registered office of this corporation is 325 Avenida Madera, Sarasota, Florida, 34242, and the name of the initial registered agent of this corporation at that address is Alfred F. Grabo. The Principal office is the same as the Registered office.

#### **ARTICLE VI**

<u>Preemptive Rights.</u> Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his/her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

# **ARTICLE VII**

Number of Directors. The Board of Directors of this corporation shall consist of one or more directors, the exact number of which shall be the number of directors from time to time fixed by the Board of Directors or the stockholders in accordance with the ByLaws of the corporation. Directors, as such, shall receive such compensation for their services, if any, as may be set by the Board of Directors at an annual or special meeting. The Directors may authorize and require the payment of the reasonable expenses incurred by directors in attending meetings of the directors. Nothing in this Article shall be construed to reclude a director from serving the corporation in any other capacity and receiving compensation therefor.
