ARTICLES OF INCORPORATION OF ELETE UPHOLSTERY OF SARASOTA, INC.

ARTICLE I

Name. The name of this corporation is ELETE UPHOLSTERY OF SARASOTA, INC.

ARTICLE II

Duration. The corporation shall be perpetual.

ARTICLE III

<u>Purpose</u>. This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV
