ARTICLES OF INCORPORATION
OF
CONSOLIDATED SERVICES OF BREVARD, INC.

EFFECTIVE DATE

The undersigned incorporator, being a natural person competent to contract, hereby adopts these Article of Incorporation in order to form a corporation under the laws of the State of Florida.

Article I - NAME

The name of this Corporation is Consolidated Services of Brevard, Inc.

Article II - TERM OF EXISTENCE

This Corporation shall commence upon the execution of these Articles and shall exist perpetually.

Article III - NATURE OF BUSINESS

The purpose of this Corporation is to engage in any business lawful under the laws of the State of Florida and the United States.

Article IV - SHARES

This Corporation is authorized to issue Ten Thousand (10,000) shares of \$1.00 par value, common stock. The rights attendant to all such shares, once issued, shall be identical in all respects.

The shares of this Corporation are not to be divided into classes. This Corporation is not authorized to issue shares in series or in less than whole shares.

Article V - PREEMPTIVE RIGHTS

Every Shareholder, upon the issuance of any new stock of this Corporation, shall have preemptive rights to purchase his or her pro-rata share thereof (as nearly as can be done without issuing fractional shares), at the price at which it is offered to others.

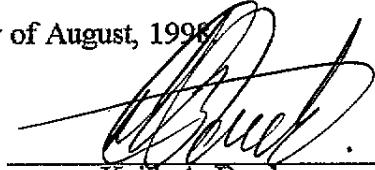
Article VIII - AMENDMENTS

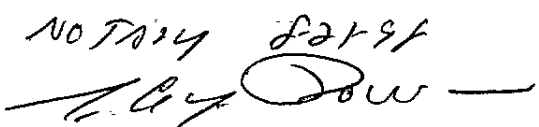
