

ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation.

ARTICLE ONE

NAME

The name of the corporation is RPD ENTERPRISES, INC..

ARTICLE TWO

DURATION

The term of existence of the corporation shall be perpetual.

ARTICLE THREE

PURPOSE

The purpose for which the corporation is organized is to engage in the purchase, rehabilitation, modification, repair and sale of mobile homes, mobile home additions, and real property associated with mobile homes, and to engage in any other business activity for profit; the corporation may, however, transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE FOUR

CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is 720 all of which shall be common shares of

par value of \$1.00 per share.

PREEMPTIVE RIGHTS GRANTED


