#### ARTICLES OF INCORPORATION

. The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of a corporation for profit.

## ARTICLE I

The name of this corporation shall be:

J. R. K. TRANSPORT, INC.

Its business shall be carried on in the County of Dade, State of Florida, and in the United States of America.

#### ARTICLE II

The general nature of the business and the objectives and purposes proposed to be transacted and carried on are to do any and all of the things herein mentioned, as fully and to the same extent as a natural person might or could do, viz:

- a.) To engage in the business of interstate and intrastate trucking, transportation, moving, storage, delivery, courier services, and related trucking and transportation services and operations; and to in general conduct business in the transportation, trucking, moving business and all related products and services; to deal in general in the transportation and trucking business; to supervise and or operate as a consultant in all phases of the general transportation and trucking business; and to engage in business as a transportation and / or trucking and / or distribution company and / or consultant; and to conduct any and all business(es) pertaining to such a company; and to perform any and all acts necessary to the accomplishment and furtherance of the above stated purposes.

- c.) To conduct business or businesses in and have one or more offices in the State of Florida, and in any and / or all other states and countries; to conduct the business of transportation, trucking and moving and of all related services; and to operate as a transportation and trucking company, and to engage in any and all related businesses, sales or services related to a transportation and trucking

business; and in general to do everything suitable, necessary, proper and conducive to the successful operation of a transportation and trucking company and / or consultant or management company.

d) In general to conduct and operate any and all businesses and business activities for which a corporation is currently authorized to conduct or operate under the laws of the State of Florida or as a corporation may in the future be authorized to conduct or operate.
