The name of this corporation is:

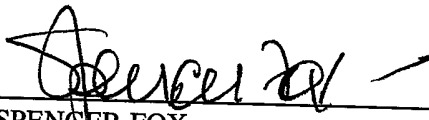
ARTICLE VIII

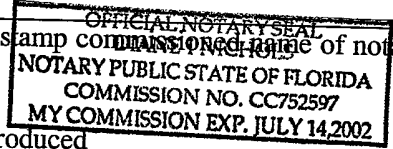

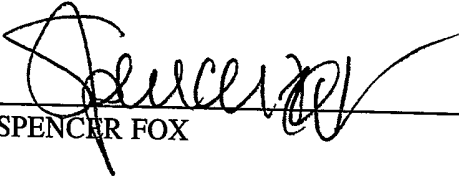
