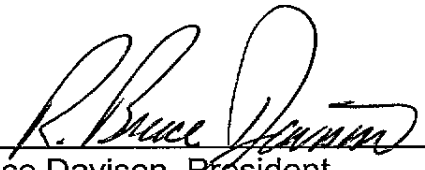
SECOND: The date of the adoption of these Articles of Dissolution is 17 May 1999.
