ARTICLES OF INCORPORATION

OF

The undersigned, being an individual, does hereby act is incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "Corporation") is TOOLS FOR SUCCESS INC.

SECOND: The address, wherever located, of the principal office of the Corporation, if known, is 9214 Mill Circle, Tampa, Florida 33647-2820.
