The undersigned, for purposes of forming a corporation under the Florida general corporation act, hereby adopts the following Articles of Incorporation:

ARTICLE I - PURPOSES AND OBJECTS

The Corporation is formed pursuant to the Professional Service Corporation Act and for the purposes and objects of rendering the same professional services to the public that a duly licensed attorney is authorized to render. The Corporation may engage in the aforementioned business or specific profession and in any other transaction or business permitted under the laws of the United States of this State.

ARTICLE II - DURATION

The duration of this Corporation shall be perpetual. Corporate existence shall commence upon the filing of these articles with the Department of State provided that all of the requirements of the law are met.

ARTICLE III - REGISTERED OFFICE - AGENT

The name of the Registered Agent is Jason Scott Coupal, and the street address of the Registered Agent is 1975 E. Sunrise Blvd., Suite 513, Fort Lauderdale, Florida 33304.

ARTICLE IV - NUMBER OF DIRECTORS

The Corporation shall have one (1) director constituting the initial board of directors. The number of directors may be either increased or decreased from time to time by the by-laws. The name and address of the initial board of directors is:

ARTICLE X - INDEMNIFICATION

The Corporation shall indemnify any officer, director, or any former officer or director, to the full extent permitted by law.
