Thank you for assisting us by providing the follow-up information we requested to reinstate our Corporation  
(Mr. Mo Jobs Placement, Inc.) Doc.Num. P98000074963

The reason we did not file our first annual report as requested is because the then presiding CEO made bad management decisions, diverted funds and kept job records that were essential to our financial status. Which we recently found that our corporation lost a total of \$21,759.01 from August 1998-August 1999. We have since voted to remove him from the company and reorganize our internal controls. We learned by that experience and paid a high price by giving too much control to one individual. Mr. Mo Jobs corporation was dormant until April 1999 this was a period of about eight months since the initial loss of \$21,992 in August-Sept 1998 on the one contract secured by the CEO.

We respectfully request reinstatement to further our endeavors as a small corporation and thank you for your consideration.
