Enclosed please find my annual report for Paul J. Kneski, P.A., together with regular filing fee in the sum of \$150. I would respectfully request that you waive any penalty for late filing due to the circumstances explained below.

You did not mail me my annual report form until the end of last week. When I failed to receive the report form I called your office and requested over the telephone that you immediately send me the form so that I could immediately and timely complete it and return it to you together with the regular filing fee. Notwithstanding my request, you failed to mail the form to me until now, after the May filing deadline. I could not timely file the form although I wanted to and would have, had I received it when I requested it from you. I do not think it is fair that I be required to pay a \$350 penalty when in good faith I tried to comply but was unable to do so. My experience is not unique as my brother, Peter Kneski (Peter Kneski, P.A.), has had the same experience that I had.
