ARTICLES OF INCORPORATION  
OF  
BK PROPERTIES, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

**EFFECTIVE DATE**

8-24-98

Corporate Name and Principal Office

The name of this corporation is BK PROPERTIES, INC. and its principal office and mailing address is 2112 N. 15<sup>th</sup> Street, Suite 300, Tampa, FL 33605.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on August 24, 1998.

ARTICLE III

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

ARTICLE IV

Capital Stock

The aggregate number of shares of stock authorized to be issued by this corporation shall be 100,000 shares of common stock, each with a par value of \$.01.
