ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be:

Service Source Advantage, Inc.

ARTICLE II: DURATION

The corporation shall have perpetual existence.

ARTICLE III: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 2150 Whitfield Industrial Way, Sarasota, Florida 34243.

ARTICLE IV: CAPITAL STOCK

The total number of shares of stock which the Corporation shall have authority to issue is Five Hundred (500) shares of Common Stock having a par value of \$1.00 per share, of which Four Hundred (400) shall be designated as Voting Common Stock and One Hundred (100) of which shall be designated as Non-Voting Common Stock.

The relative rights, privileges and limitations of the Voting Common Stock and Non-Voting Common Stock are to be the same, except that holders of the shares of Voting Common Stock shall exclusively possess voting power for the election of directors and for all other purposes, and the shares of Non-Voting Common Stock shall not entitle the holders thereof to vote in any election of directors or for any other purpose; provided, however, that each share of

Non-Voting Common Stock shall entitle the holder there of to one (1) vote in every case where such vote is expressly required by law.


ARTICLE V: INITIAL REGISTERED AGENT AND ADDRESS


