# ARTICLES OF INCORPORATION OF BOWEN ALUMINUM, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

# ARTICLE I

Name

Name of the corporation is BOWEN ALUMINUM, INC.

## ARTICLE II

Duration
