CERTIFICATE OF INCORPORATION
OF

We, the undersigned, hereby execute this document for the purpose of doing business as a corporation under the laws of the State of Florida, providing for the formation, liability, rights and privileges and immunities of a corporation for profit.

ARTICLE I
NAME OF CORPORATION

The name of this corporation shall be: Tropic Pools

ARTICLE II
GENERAL NATURE OF BUSINESS

The general nature of the business and the objects and the purposes proposed to be transacted and carried on, are to be any and all things hereinafter mentioned, as freely and the same extent as natural persons might or could do, viz;

(a) To engage in every aspect and phase of the business of swimming pool construction and maintenance, selling commodities and the conducting of the general support services connected with that business and business of all kinds and descriptions and such other and further services as may be necessary and incidental to the carrying

on of such business in connection therewith on a retail and wholesale business.

(b) To engage in every aspect and phase of the business of swimming pool construction, advisement, and all such services in connection therewith, on a retail and wholesale basis.

(c) To engage in every aspect and phase of the business of selling equipment or commodities connected to or supporting the services listed in (a) and (b) above.

(d) To borrow money for its corporate purposes and to make, accept, endorse, execute and issue promissory notes, bills of exchange, bonds, debentures, other obligations, from time to time, for the purpose of purchasing property, or for any purpose in or about the business of the company, and if deemed proper to secure the payment of any such obligations by mortgage pledge, deed of trust, or otherwise.

(e) To sell, improve, manage, develop, lease, mortgage, dispose of, or otherwise turn to account or deal with all or any part of the property of the company.

ARTICLE III

CAPITAL STOCK

The amount of capital stock of this corporation shall be divided into one hundred (100) shares of common stock, without nominal or par value, all of said stock shall be payable in cash, property, labor or services, a par valuation to be fixed by the Board of Directors of the corporation.

ARTICLE IV

The amount of capital with which this corporation shall commence business shall not be less than One Thousand (\$ 1,000.00) dollars.

ARTICLE V

This corporation shall have a perpetual existence unless sooner dissolved according to law.

ARTICLE VI

INITIAL REGISTERED OFFICE AND AGENT

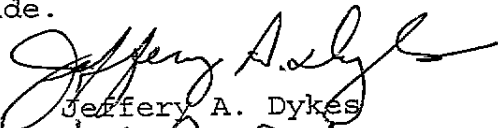
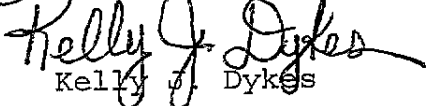
