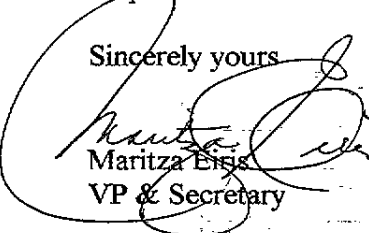

ARTICLE I  
CORPORATION NAME

The name of this Corporation shall be: GOMEIRIS AVIATION, INC.

ARTICLE II  
PRINCIPLE PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III  
NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this

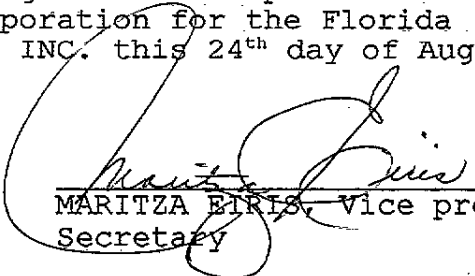
