of

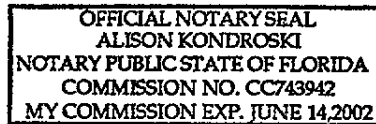


