I, the undersigned, natural person competent to contract, hereby associated myself for the purpose of becoming a corporation under the laws of the State of Article State of Plorida, providing for the formation of a corporation for profit, with the powers, rights, privileges and immunities hereinafter, and do make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation, and to that end I do by these Articles set forth:
