## ARTICLES OF INCORPORATION OF

### "CHILDREN FIRST" DEVELOPMENT CENTER, INC

ARTICLE I

The name of the corporation shall be "Child First" Development Center, Inc. This corporation is organized pursuant to the Florida For Profit Corporation Codes.

ARTICLE II
