

**ARTICLES OF INCORPORATION**  
**OF**  
**SPIN ENTERPRISES, INC.**

The undersigned incorporation hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I**

The name of the Corporation shall be **Spin Enterprises, Inc.**

**ARTICLE II**


### **ARTICLE X**

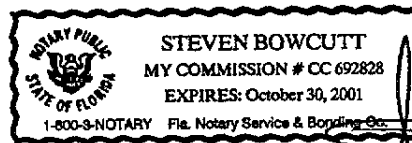


