**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
IGP EVENT LINKS, INC.**

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the Corporation is IGP Event Links, Inc.
2. The following provisions of the Articles of Incorporation of IGP Event Links, Inc., a Florida corporation, filed in Tallahassee on August 31, 1998, be and they hereby are amended as follows:

ARTICLE I – The name of this Corporation shall be and hereby is amended to read as follows:

“The name of this Corporation shall be: EVENT LINKS INTERNATIONAL, INC.”

3. The foregoing amendments were adopted by the Incorporator without shareholder action and shareholder action was not required.
