ARTICLES OF INCORPORATION OF KIR & COMPANY, INC.

THE UNDERSIGNED, acting as sole incorporator of KIR & COMPANY, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:
