**ARTICLES OF INCORPORATION  
OF

**THE UNDERSIGNED**, acting as sole incorporator of KIR & COMPANY, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I  
NAME**

The name of the corporation is KIR & COMPANY, INC.

**ARTICLE II  
SHARES**
